¹ In lieu of IRS EIN Letter a Tax Return may be used.

² Trade Name Certificate is applicable if the owner's last name is not included in the business name.

³ In lieu of Meeting Minutes, authorizing account & signatory, Patriot's Authorization Designation form can be completed.

 $^{^4}$ Non-Profit 501(c)3 status will require the Determination Letter for Non-Profit Organization.
